## **ABOUT THE BIGHT**

The Great Australian Bight is a globally significant ecosystem and one of the most unspoiled marine environments in the world.

The coastal span of the Bight - over 1200 kms - has supported many different Aboriginal groups for tens of thousands of years. The connection to country remains strong today. The Bunda cliffs and plains of the coastal Nullarbor are home to the Mirning People - the whale dreamers

The Bight supports diverse sea life such as great white sharks, humpback, blue and southern right whales, southern bluefin tuna, Australian sea lions, whitebellied sea eagle and albatross. More than 85% of the species in the Bight cannot be found anywhere else in the world.

Visiting the Head of Bight to whale watch has been named as one of the top 3 experiences in South Australia.



## **THE RISKS**

Oil companies are planning on drilling for oil off the coast of SA in the Great Australian Bight.

Modelling shows even a low flow oil spill could impact all of Southern Australia's coast, from Western Australia right across to Victoria through Bass Strait and around Tasmania. This could devastate SA's \$442 million fishing industry & coastal tourism industries worth over \$1 billion, equating to 10,000 full-time positions.

All stages of the oil development cycle - exploration, development, production, abandonment - pose unavoidable impacts. Some risks include noise pollution, smothering from seabed disturbance and drill cuttings disposal, chemical pollution and discharge of drilling fluids, accidental discharge and leakage of oil, and increased ship strikes to whales and dolphins.

Climate change is impacting our planet. At a time when we should be moving away from fossil fuels, Big Oil is opening new reserves. If we are to meet our internationally agreed targets to limit global warming below 2°C we cannot let this happen.
